# **DISCUSS TRUSTEE ITEMS**

- Member Cramer stated that the City of St. Helena has passed an order banning gas powered leaf blowers and expressed concern over the city's alarm system permit and registry.
- Member Cabral noted an increase in afternoon mosquitoes in the Carneros area; inquired on number of calls in that area.
- Member Maffei attended Career Day at the Napa Fairgrounds and noted that Peter Ozorio, District Field Operations Supervisor, was doing an excellent job at the District's booth. Member Maffei was also very impressed with Peter's ability to engage middle school teens.

## MANAGER'S REPORT

- The District area has received 34 inches of rain. Rain has District staff busy inspecting currently known sources as well as searching for possible new sources throughout the County.
- Black flies are being found instead of mosquitoes on some service calls.
- New employee to start Monday; he comes with very high recommendations. The District still has an open recruitment for one more Vector Control Technician.
- The District manager was not accepted to the Bee Workshop in Arizona.
- The District manager will participate in a bee methodology program being held in Oregon later this summer.
- District manager continues to work with Karl Malamud-Roam of Vector Control Consultants on the update of the District's PEIR
- A new board member representing the City of Napa is expected to participate at the May board meeting.
- After a long wait, the security doors are being installed at the car ports at the District office entrance.
- Wesley Maffei was interviewed by the Calistoga Tribune regarding district activities and processes for mosquito abatement. The interview to be in the newspaper shortly. Wesley expressed concerns of a proof print not being made available to him before final publication.
